APPLICATION PROCESS:

- **Fees:** Costs associated with citizenship applications, including the application fee and additional charges for biometric enrolment and the citizenship ceremony.
- **Decision and Ceremony:** What to expect after submitting the application. Successful applicants will receive an invitation to attend a citizenship ceremony, where they will take an oath of allegiance and receive their certificate of naturalisation.
